The National Board of Examinations has issued notice on 4-4-2019 regarding revised cut off score card in accordance with MOHFW letter No. V.12025/82/2018-DE dated 3<sup>rd</sup> April, 2019. The minimum qualifying percentile for MDS has been lowered in pursuance of the 2<sup>nd</sup> proviso in clause 7(1) of DCI Master of Dental Surgery (1<sup>st</sup> Amendment) Regulation, 2018 for various categories are as follow:-

Since the cut off score have been lowered as mentioned above, the applications are invited for filling-up for 50% State Quota and 50% Management Quota seats in private un-aided Dental Colleges of the State. All the eligible candidates who fulfill the eligibility criteria as per prospectus should apply on prescribed Application Form. Government Dental College & Hospital, Shimla on or before 8-5-2019 (up-to 5:00PM)**

The candidates who will apply for MDS admission will be considered during the 2<sup>nd</sup> round of common counseling scheduled to be held on **15-5-2019** as per prospectus. The merit list will be displayed on the official website of H.P. Govt. Dental College & Hospital on 13-5-2019. The candidates who have applied already on or before 30-3-2019 need not to apply again and application form should be filled in correctly.
