- No admissions shall be made by the institution over and above the intake capacity approved by the Dental Council of India (DCI)/National Dental Commission (NDC) and permitted by AMRU.
- The institution shall not commence any new course, alter the approved intake capacity, or discontinue any existing course without obtaining prior approval of the Dental Council of India (DCI)/National Dental Commission (NDC) and AMRU.

d) The institution shall charge tuition fee and other fees only as prescribed by the Government of Himachal Pradesh and/or AMRU.

e) Strict compliance with the Anti-Ragging Regulations and all applicable guidelines issued by the UGC/DCI/NDC/AMRU/State Government shall be ensured.

f) The institution shall strictly comply with the curriculum, academic calendar, examination regulations, internship regulations, attendance requirements and all other academic and administrative directions issued by the DCI/NDC and AMRU from time to time.

Additional Instructions / Recommendations

1. All deficiencies pointed out by the Inspection Committee/Scrutiny Committee shall be rectified within the stipulated period.
2. The institution shall maintain faculty strength, infrastructure, equipment, laboratories, library, hospital facilities, clinical material and other requirements strictly in accordance with the norms prescribed by the DCI/NDC/AMRU.
3. The institution shall ensure that all statutory committees prescribed by the DCI/NDC and AMRU function regularly and maintain proper records.
