This affiliation is further subject to the following conditions. Non-compliance will invite action under the Statutes and Ordinances of AMRU:

- Submission of a compliance report in respect of the above-mentioned deficiencies, if any, along with supporting documents, within six months from the date of issue of this letter.
- No excess admissions shall be made by the institution over and above the approved intake by the Dental Council of India (DCI) and AMRU.
- The institution shall not start new courses, alter intake capacity, or close existing courses without prior approval of the DCI/National Dental Commission (NDC) and AMRU.
- The institution shall not charge tuition or other fees beyond those prescribed by the Govt. of Himachal Pradesh / AMRU.
- Strict compliance with the Anti-Ragging Regulations notified by UGC/DCI/AMRU/State Govt. is mandatory.

- f) The institution shall follow the University Calendar, syllabus, examination system, and other norms prescribed by AMRU.
- g) The institution must submit a copy of DCI approval for the academic session 2025-26 to AMRU.

Additional Instructions / Recommendations

The Inspection Committee and Scrutiny Committee further recommend the following:

1. Remove all deficiencies in respect of infrastructure, machinery, faculty, residents, and staff as pointed out by DCI inspectors.
2. Ensure fire safety measures and biomedical waste management as per prescribed standards.
3. Maintain faculty strength strictly as per DCI norms.
4. Install barbed wire fencing around hostels and maintain a visitor register under the supervision of chowkidar.
5. The Anti-Ragging Committee must regularly inspect hostels and document all visits.
6. Provide rent-free accommodation and telephone facility to faculty members serving as hostel wardens.
7. Conduct regular and surprise hostel inspections and maintain records with the Chief Warden.
8. Maintain cleanliness and hygiene throughout the campus.
9. Ensure unused equipment is commissioned and adequate manpower is recruited and trained for its operation.
10. Hold periodic meetings of College Council, Curriculum Committee, Disciplinary Committee, Anti-Ragging Committee, Sexual Harassment Committee, and other statutory committees, and send minutes to AMRU within a week. Urgent matters must be communicated immediately by the fastest mode.
11. Provide recreational facilities for students, including indoor and outdoor games. Coaches for outdoor sports may be engaged on a part-time basis, and playgrounds may be hired on a rental/request basis wherever necessary.
